In the event of infrincement/contravention or non-compliance of any of the conditions, exidelines, norms, and regulations prescribed by the AICTE from time to time the AICTE or a body or person(s) authorized by it shall be free to take measures for mithdrawal of the approprial or recognition without consideration of any related issues and that liabilities arising out of such withdrawal would be solely that of the Management/Trust/Society and/or Institutions. AICTE may inspect the institution at any time it may deen fit to note progress.

You are requested to kindly take appropriate action to implement the decision of the AICTE and continuously monitor the progress made by the institution and communicate it to the Southern Regional Committee of the AICTE under intination to this office.

Specific conditions :

- 1. The Management should construct the buildings at their permanent site as planned and start conducting the I & II year classes of the College at their permanent site from the academic year 1996-97.
- The Management should establish all the labs required for the II year classes for the courses being conducted by them before June. 1996.
- The Management should strengthen their financial position for creating infrastructural facilities for the College.
- Faculty for running the II year classes of the College for the courses being conducted should be in position by June. 1996.
- Endowment of Rs.10.00 lakhs should be transferred in joint account of College and DTE.
- 6. Library stock register should be completed by entering all the books and National & International journals should be subscribed as planned.
- 7. The Management should rectify the following deficien
 - a. Physics Lab: Dark room should be provided with work table and electrical connections.
 - b. Smithy Shop: The Management should create a separate building space for establishment of Smithy shop and mount all the equipments in that space.
- 8. The Management should submit the status report in respect of compliance of the conditions stated in (1) to (7) above to AICTE. New Delhi and Southern Regional Office. Madras by 15 May . 1996.

General Conditions

- No new course(s) shall be started or an ongoing course(s) shall be discontinued without the
- The intake capacity in any of the approved course(s) shall not be increased or varied without 2. the prior approval of the AICTE.
- Adequate funds shall be available with the Institution to meet the financial obligations of recurring and non-recurring nature as prescribed by the AICTE, from time to time.
- All infrastructural, instructional and other facilities shall be provided as per the AICTE norms 4. 5.
- Teaching and other staff shall be selected according to the procedure, qualifications, experience and pay scales as prescribed by AICTE from time to time, and that they shall be paid full salaries
- The tuition and other fees shall be charged as prescribed by the State Government within the overall criteria/limits as may be laid down by the AICTE from time to time. 7.
- Admissions shall be made according to the regulations and directions of the AICTE for such admissions in the respective technical institution or university. 8.
- The State Government policies for admissions of SC/ST, other weaker sections of Society etc., 9.
- Institution by virtue of the approval by AICTE shall not automatically become eligible to receive financial grants or assistance from the Central or State Governments.
- Institution shall maintain records and books of accounts as prescribed by the Competent
- 11. The Accounts of the Institution shall be audited by Chartered Accountant or any agency authorised by the Competent Authority and shall be open for inspection by the AICTE or any
- 12. The Institution shall be subject to a Special Audit and inspection as prescribed by the AICTE.
- 13. Institution shall furnish requisite returns as prescribed by Competent Authority/AICTE for ensuring
- 14 The Institution may be visited by an officer or a Committee of the AICTE or of its Regional Office from time to time to review the progress made by the Institution in fulfilling the conditions as

Additional Conditions for Pvt. and Grant-in-Aid technical institutions:

- 15. The Governing Body of the institution shall be constituted, and its Chairman shall be appointed
- 16. The institution shall not charge any Capitation Fee or donation for admission or other higher charges from the students/guardians of the students in any form.
- 17. The Institution shall constitute a Planning and Monitoring Board (PMB) for the continuous monitoring of implementation of norms and standards of the AICTE. There shall be an evaluation of the Institution in a plan period by the AICTE.
- 18. The institution should create an Endowment fund jointly in the name of the institution and the concerned State Authority to the tune of 30% of the projected peak annual recurring expenditure or as prescribed by the State Govt./UT or Rs. 10 lakhs, whichever is more.
